OPEN NATIONAL AND INTERNATIONAL CALL FOR CONSULTANCY SERVICES

The Cameroon Baptist Convention (CBC) Health Services is seeking a Consultant to conduct an Eye Care Situational Analysis of the Northwest Region using the WHO ECSAT Tool. The purpose of this analysis is to determine the current state of Eye Care Services in the Region, and its capacities, determine priority gaps for future intervention, and ascertain key stakeholder plans and priorities.

The Consultant will be responsible for conducting a comprehensive review of the Eye Care system in the Northwest Region, including the availability and accessibility of Eye Care Services, the quality of care provided, and the existing policies and regulations governing Eye Care. The Consultant will also be expected to engage with key stakeholders, including Government officials, health care providers, and community members, to gather their perspectives on the state of Eye Care in the Region.

Consultant Profile

The skills, expertise, knowledge, and abilities required of potential candidates are:

- A strong background in Public Health, with specific expertise in Eye Care and developing National eye health plans and strategies.
- Experience conducting situational analyses using the WHO ECSAT Tool is highly desirable.
- Excellent knowledge about Inclusive Eye Health and Disability
- Experience working in Eye Health in Africa, especially in the Central African context and an Ophthalmology/Public Health background would be desirable.
- Fluent in English and have experience in writing high-level reports for international organizations and WHO
- Knowledge of the Northwest Region (Socio-political context, language particularly pidgin, and culture) is relevant.
- The Consultant should also have excellent communication and interpersonal skills, as well as the ability to work independently
 and manage multiple tasks simultaneously.

Interested candidates with the required qualification and skills mentioned above should submit an expression of interest including;

- 1. A cover letter addressed to the CBC Director of Health Services, outlining their qualifications and experience,
- 2. A technical proposal with a proposed methodology for conducting the situational analysis
- 3. A budget and timeline for completing the Project.
- 4. Curriculum Vitae (CV).
