Call for Tender for Car Rental Services

Description of the organization:

The Cameroon Baptist Convention Health Services (CBCHS) is a Non-profit, Faith-based, Humanitarian and Inclusive Organization that offers holistic care to all who need it as an expression of Christian love. Established in 1936 by missionaries, it was transitioned to local leadership in 1975. It runs 12 hospitals, 32 Integrated Health Centers, and 61 Primary Health Centers in eight of the ten regions of Cameroon. The CBCHB runs public health programs in all the 10 regions of Cameroon including HIV/AIDS care and treatment, NCD, Women health, disability programs, etc. It has a staff capacity of over 6,000 full-time employees. The CBCHB is the leading local organisation that supports the MoH in HIV prevention, care and treatment, system strengthening including strategic information, clinical services, and program management. It is currently one of the key implementing partners of the PEPFAR funded grants in Cameroon with its roots in comprehensive, community and family focused HIV services.

Project description:

In partnership with the Government of the Republic of Cameroon, United States Centers for Disease Control and Prevention (CDC) and other key stakeholders, CBCHB will conduct the second Cameroon Population-based HIV Impact Assessment (CAMPHIA). This will be a nationwide study. The first study was implemented in 2017-2018 and now the second study will be implemented in 2024. Described as CAMPHIA 2024, the study will evaluate the impact of the national HIV epidemic response and guide data-informed strategies to achieve and sustain HIV epidemic control in Cameroon.

The CBCHB is looking to hire the services of a car rental agency to help with its implementation of The CAMPHIA 2024 survey project.

Terms & Conditions:

- 1. Car rental agency will be responsible to provide its services all over Cameroon.
- 2. Vehicles will be provided according to the CBCHB specifications on need bases.
- 3. The car rentals must be signed by designated CBCHB employee and CBCHB will not be responsible for any expense related to the driver (e.g. stay, lunch etc.) otherwise stated.
- 4. In case of a car breakdown or problem with the chauffeur, an immediate replacement will be given by the agency without any additional cost.
- 5. All operational costs e.g. car maintenance, toll & parking will be catered by the service provider.
- 6. All car documents, tax documents, insurance and other relevant car vendor documents should be quoted in the bid.
- 7. All Government applicable taxes will be deducted from the service provider's payment.
